IV. Agenda Items for Individual Consideration

A. Discussion and possible action regarding approval of Novation Agreement between Red River Army Depot, TexAmericas Center, and Riverbend Water Resources District authorizing the transfer of US Army Contract.

Liz Fazio Hale provided an update that the Novation Agreement had been prepared by TexAmericas Center and approved by the local contracting authority with the Red River Army Depot. Once the District approves the Novation Agreement, it will go back to TexAmericas Center and the federal government for approval and completion of a modification of the contract.

Liz Fazio Hale provided an update on the bond resolutions. Once the Novation Agreement is signed by all parties the financial advisors will work with all interested parties to update the bond resolutions for signature.
