The North East Texas Regional Water Planning Group (NETRWPG) – Region D met in an open meeting on Wednesday, September 23, 2015, at 1:00 P.M. The meeting was held at the Mount Pleasant Civic Center, 1800 N. Jefferson, in Mount Pleasant, Texas. Notice of the meeting was legally posted.

Chair Linda Price called the meeting to order at 1:00 and welcomed everyone. Bob Staton gave the invocation. Introductions were made and a quorum was present. Seventeen members of the planning group were present in person or represented by a designated alternate.

## NETRWPG Minutes for September 23, 2015

David Nabors made a motion to approve the minutes from the August 26, 2015 meeting. Robert Holt seconded the motion. Motion carried, all voting aye.

According to the Region D Bylaws, any vote requiring a two-thirds majority of the voting members is required to be made when three-fourths of the members are present. This requires the presence of eighteen voting members either in person or by an alternate. Accordingly, no action was taken to approve Agenda Item #4 (Consideration and action of successor for the resigned voting member Drew Roberts, representing Rains County and Municipalities), Agenda Item #5 (Election of Officers for Regional Water Planning Group Area-D), and Agenda Item #10 (Consideration and action on Water Management Strategies for the Cities of Canton and Clarksville, Texas).

Temple McKinnon stated that the Texas Water Development Board reassesses boundaries every five years and that the Executive Board recommended no changes. Mrs. McKinnon mentioned that three comments had been received requesting Red County to move to Region C. Mrs. McKinnon reported that action by TWDB was deferred until the next meeting of TWDB on October 13<sup>th</sup>.

George Frost made a motion to authorize Linda Price to communicate to the TWDB on mitigation and future funding. Jerry Gaskill seconded the motion. Motion carried, all voting aye.

David Nabors made a motion to select and authorize Carollo Engineers as consultants for Round 5 regional water planning as proposed by Carollo Engineers. Rick Ivey seconded the motion. Motion carried, all voting aye.

David Nabors mentioned that Region C will meet on September 28<sup>th</sup> with an agenda of regular housekeeping. Temple McKinnon stated that the TWDB will meet on October 13<sup>th</sup> to consider boundaries and additional topics.

Tony Smith gave a brief status report along with a presentation discussing considerations for the Water Management Strategy Options involving the City of Canton and the City of Clarksville. Mr. Smith recommended Option A for the City of Canton in which recommended strategies include: drilling a new well and indirect/direct reuse with an alternative strategy: build Grand Saline Creek Reservoir. Mr. Smith made two recommendations regarding the City of Clarksville. First, Mr. Smith proposed adding additional language to include study analysis of further vetting of possible options, thus, enabling the City of Clarksville access to TWDB funding. Mr. Smith recommended the following proposed language be added to the Region D Plan: "At present, considerable uncertainty exists in each of the identified feasible water management strategies for the City of Clarksville. The NETRWPG supports any efforts by the City of Clarksville to further study all potential strategies to identify the best approach for the City to meeting all of its future water supply needs, and such a study should be considered consistent with the 2016 North East Texas Regional Water Plan." Mr. Smith also recommended Option C for the City of Clarksville with the recommended strategy: build a pipeline to DeKalb and the following alternative strategies: build Dimple Reservoir, drill additional wells and RO, and install a

pipeline connection to Paris. During the presentation, the following people addressed the planning group: Canton Mayor Pro Tem Shawn Stewart, Clarksville Mayor Ann Rushing, Clarksville City Manager Wayne Dial, and Red River County Judge L.D. Williamson.

David Nabors made a motion to approve the Financial Report by the Administrator, including approval for payment of the RPS/Espey Consultant invoices. Bob Staton seconded the motion. Motion carried, all voting aye.


By consensus, the next meeting of the regional water planning group was set for October 21, 2015.
